ORDER DENYING MOTION FOR REHEARING

UPON CONSIDERATION of the motion of the Stockbridge-Munsee Community, filed herein on May 7, 1973, for rehearing of the order of the Commission entered April 4, 1973, at 30 Ind. Cl. Comm. 40, denying the prior motion of the Stockbridge-Munsee Community to intervene in the claims before the this Commission in Dockets 27 and 27-E, brought by the Delaware Tribe of Indians, and in Docket 202, brought by the Absentee Delaware Tribe of

Oklahoma, et al., and the responses in opposition to said motion for rehearing filed by the Delaware plaintiffs in Dockets 27, 27-E and 202, and by the Potawatomi plaintiffs in Dockets 29-E and 29-G, the Commission has concluded that the Stockbridge-Munsee Community has failed to state any valid grounds under the Commission's Rules of Procedure upon which said motion should be granted.

AND FURTHERMORE, it appearing to the Commission that the decision of the Court of Claims in the case of <u>United States v. Kiowa, Comanche and Apache Tribes</u>, Appeal No. 12-71 (Ct. Cl., June 20, 1973), slip op. at 13-14, reversing the decision of the Commission in Docket 257, 24 Ind. Cl. Comm. 101 (1971), permitting the Wichita Indian Tribe of Oklahoma to intervene in said claim, in any event forecloses any basis for intervention by the Stockbridge-Munsee Community in the cases captioned above,

IT IS THEREFORE ORDERED that the motion of the Stockbridge-Munsee Community for rehearing be, and the same is hereby, denied.
