FINAL ORDER DISMISSING THE CLAIMS IN DOCKETS 13-G, 18-M AND 40-F AND DISMISSING DOCKET 89, AND INTERLOCUTORY ORDER IN DOCKETS 15-E, 27-B, 29-C, 64, 120, 130, 252, 335 AND 338

Upon the findings of fact, conclusions of law and opinion this day filed herein and which are hereby made a part of this order,

IT IS HEREBY ORDERED that the claims in Dockets 13-G, 18-M and 40-F be, and the same are hereby, dismissed;

IT IS FURTHER ORDERED that Docket 89 be, and the same is hereby, dismissed; and

IT IS FURTHER ORDERED that the claims in Dockets 15-E, 27-B, 29-C, 64, 120, 130, 252, 335 and 338, proceed for the purpose of determining the acreage and fair market value as of August 3, 1795, of the lands found herein to have been aboriginally owned by the predecessors of the plaintiffs in these dockets as of said date, the consideration paid by the United States at the 1795 Treaty of Greeneville, 7 Stat. 49, and all other issues bearing upon the question of defendant's liability in the premises.
