ORDER AMENDING FINDINGS AND ORDER AND ADMITTING EXHIBITS

Based upon the supplemental findings of fact accompanying and hereby made part of this order, and for the reasons stated in the accompanying opinion which is also hereby made part of this order, it is hereby ordered that:

- 1. Finding of fact No. 25, previously entered herein on March 30, 1971, 25 Ind. Cl. Comm. 179, 209, is vacated.
- 2. Finding of fact No. 26, previously entered herein on March 30, 1971, 25 Ind. Cl. Comm. 209-10, as amended by Commission order of November 11, 1971, 26 Ind. Cl. Comm. 336, 364, is further amended by changing the dates "April 12, 1870" in the first paragraph and "1870" in the second paragraph to "May 20, 1891," and by redesignating said finding of fact No. 26 as finding of fact No. 33.
- 3. Finding of fact No. 27, previously entered herein on March 30, 1971, 25 Ind. Cl. Comm. at 210-11, is redesignated as finding of fact No. 34.
- 4. Clause 3 of the order entered herein on March 30, 1971, 25 Ind. Cl. Comm. 212, 213, is amended by deleting the phrase "until April 12, 1870" appearing in the last line.
- 5. Clause 5 of said order is amended by changing the date "April 12, 1870" appearing in the second and third lines to "May 20, 1891".
- 6. Clause 6 is amended by changing the date "1870" appearing in the second line to "May 20, 1891".
- 7. Clause 7 of said order is vacated and replaced by the following clause 7:

- 7. The aboriginal title of the Mandan, Hidatsa and Arikara Tribes to their lands in the present State of North Dakota was extinguished on the date the agreement of December 14, 1886, between the United States and the three affiliated tribes became effective. This date was May 20, 1891, the date the President proclaimed that the three affiliated tribes had accepted the modifications made by Congress to said agreement.
- 8. The last paragraph of said order is amended by changing the date "April 12, 1870" appearing in the third line to "May 20, 1891".

IT IS FURTHER ORDERED that Plaintiffs' Exhibit Nos. DT-1 through DT-94, filed herein on February 16, 1972, Plaintiffs' Exhibits Nos. DT-95 and DT-96, filed herein on February 18, 1972, and Defendant's Exhibit Nos.
