ORDER GRANTING MOTION TO SEPARATE
WATER CLAIM OF PYRAMID LAKE PAIUTE
TRIBE FROM DOCKET NO. 87-A AND FOR
LEAVE TO FILE AMENDED AND SUPPLEMENTAL
PETITION IN DOCKET NO. 87-A

On July 2, 1975, counsel for plaintiffs filed a motion for an order (a) providing for the separation of the Pyramid Lake water claim of one of the plaintiffs herein*, the Pyramid Lake Paiute Tribe, from all other claims in Docket No. 87-A and for the assignment of said water claim to a new case, designated as Docket No. 87-B and (b) accepting for filing in Docket No. 87-A an amended and supplemental petition setting forth all remaining claims in Docket No. 87-A, copies of said amended and supplemental petition having been submitted with the motion.

THE COMMISSION having considered said motion, and it appearing from the record and from representations by plaintiffs' counsel at the hearing held on July 14, 1975, on the compromise settlement of the water claim of the Pyramid Lake Paiute Tribe that, pursuant to a joint motion for entry of final judgment on the water claim, accompanied by a stipulation for entry of final judgment, also filed on July 2, 1975, the parties, by their attorneys, have agreed to said separation of the water claim and its assignment to a new docket and to the filing of a new amended and supplemental petition in Docket No. 87-A, and the Commission being satisfied that the granting of said motion is appropriate and will permit the final disposition of the water claim by entry of final judgment thereon in Docket No. 87-B,

IT IS HEREBY ORDERED that said motion be, and the same hereby is, granted; that the said water claim be, and the same hereby is, assigned to a new docket, designated as Pyramid Lake Paiute Tribe, Plaintiff, v. United States of America, Defendant, Docket No. 87-B; and

* The original petition lists "The Pyramid Lake Tribe of the Pyramid Lake Reservation" and four other tribes and one "colony" as petitioners.

IT IS FURTHER ORDERED that the amended and supplemental petition in Docket No. 87-A, which was submitted with said motion, be, and the same hereby is, accepted as filed as of the date of this order.
