THE UNITED STATES COURT OF CLAIMS


On September 28, 1978, Paul G. Reilly, Sr., Esquire, attorney of record for the plaintiffs in the above-captioned cases, filed two applications for reimbursement of expenses. One in Seneca-Cayuga Dockets 341-A, B, C, and D, and Cayuga Docket 343. The other in Seneca Nation Dockets 342, 342-A, B, C, D, E, F, G, H, and I; Tonawanda Dockets 368 and 368-A; and Six Nations Dockets 84, 89 and 344. Mr. Reilly's applications are the only matters pending in these cases. Tuscarora Docket 321 is included in this order in the expectation that Mr. Reilly will want to file a claim for reimbursement of expenses in that case. There being insufficient time remaining to it to complete adjudication of the attorney expense applications, the Commission, pursuant to Public Law 94-465, approved October 8, 1976 (90 Stat. 1990),

ORDERS that the above-captioned cases be, and they hereby are, certified and transferred to the United States Court of Claims, and


IT IS FURTHER ORDERED that the Clerk of the Commission shall place in the file of each of the above-captioned cases the docket


book entries pertaining thereto and a copy of this order, and file a copy of this order with the Clerk of the United States Court of Claims.


