THE UNITED STATES COURT OF CLAIMS



IT IS FURTHER ORDERED that the Clerk of the Commission shall place in the file of each of the above-captioned cases the docket book entries


pertaining thereto and a copy of this order, and file a copy of this order with the Clerk of the United States Court of Claims.


