
ORDER CERTIFYING AND TRANSFERRING CASES TO

Interlocutory awards, subject to offsets, were entered in the above-captioned cases on August 25, 1978 (42 Ind. Cl. Comm. 354-523). On September 20, 1978, a final award was entered in the Potawatomi Dockets 15-D, 29-B, and 311, and in Dockets 313 and 314-A, all of which are subject to appeal (43 Ind. Cl. Comm. 308-310). There being insufficient time remaining for it to complete the adjudication of these cases, the Commission, pursuant to Public Law 94-465, approved October 8, 1976 (90 Stat. 1990),


ORDERS that said cases be, and they hereby are, certified and transferred to the United States Court of Claims, and


